**Management System:** The fishery is managed by the Western Australia Department of Fisheries through a combination of input controls (limited entry, seasonal closures, gear restrictions and operational controls), implemented under the Fish Resources Management Regulations 1995 and the Shark Bay Prawn Limited Entry Fishery Notice 1993.

**Chain of Custody:** All members of the SBPTOA are members of the client group, and eligible to use the MSC logo. Fishing does not occur beyond the SBPMF fishing area. VMS records assure that the vessels do not fish out of area. CoC starts after the first point of sale from any members of the client group, or at the first point of repackaging, secondary processing or sale to the general public, whichever comes first. That is, each buyer and each repacker, each secondary processor, and each seller of prawns to the public must have CoC. The ports of landing are restricted to Carnarvon, Geraldton, and Fremantle.
